

Website Privacy Policy

Your privacy is important to Chattanooga Web Design. Please read this privacy notice carefully as it contains important information on who we are, how and why we collect, store, use, and share personal information, your rights in relation to your personal information and on how to contact us or Supervisory Authority in the event you have a complaint.

1. Who We Are

My Web Exposure, LLC. (doing business as Chattanooga Web Design) collects, uses and is responsible for certain personal information about you.

2. Children's Online Privacy Protection Act

This website and any products and services offered herein are not intended for persons under the age of 13. Chattanooga Web Design does not knowingly collect information from anyone under 13 years of age. Chattanooga Web Design prohibits children under the age of 13 from using all interactive portions of this website, including leaving any comments, filling out forms, or otherwise submitting information. Chattanooga Web Design will not knowingly collect personally identifiable information from children under 13. If Chattanooga Web Design learns it has any information or content from anyone under the age of 13, it will delete that information.

3. The Personal Information We Collect and Use

a. *Information Collected by Us*

Chattanooga Web Design may collect, use, and is responsible for certain personal information that you provide when you voluntarily sign up for e-mails or free gifts, register for a class or presentation, leave comments, order a service or product, fill out any type of form, access private membership pages, or otherwise contact via an online form or e-mail. The information collected may include your name, e-mail, address, phone number, and/or billing information. You are not required to provide any personally identifiable information to merely access or visit this website.

Chattanooga Web Design may collect domain information and "cookies" (small files saved on your hard drive by your web browser) to analyze website and advertisement performance, track user patterns, save information from your previous visits and customize your experience. We will ask for your consent to allow us to use cookies. Chattanooga Web Design or its third-party vendors may collect nonpersonal information through the use of these technologies. Nonpersonal information might include the browser you use, the type of computer you use and technical information about your means of connection to this website such as the operating systems and the Internet service providers utilized and other similar information. Chattanooga Web Design's systems may also automatically gather information about the areas you visit and search terms you use on this website and about the links you may select from within this website to other areas of the Internet.

If you are located in the European Economic Area (EEA), we are regulated under the General Data Protection Regulation which applies across the European Union (including in the United Kingdom) and we are responsible as controller of that personal information for the purposes of those laws.

b. *How we use your personal information*

Chattanooga Web Design collects such information in order to send e-mails, fulfill orders, deliver services and products, complete customer transactions, oversee contests and promotions and improve website performance and customer service.

c. ***Who We Share Your Personal Information With***

Chattanooga Web Design respects your privacy and will never sell, trade or transfer your personally identifiable information to third parties (beyond what is necessary for fulfilling a customer transaction or for the basic functionality of an online service) without your consent

We do, however, share information required in order to conduct business by providing such pertinent information to our third-party suppliers and credit card processors. Those third-party recipients are based outside the European Economic Area.

Chattanooga Web Design may release personal information to enforce its Website Terms and Conditions of Use, other Terms and Conditions, manage its business, protect users or the general public, or to otherwise comply with legal obligations.

If you give Chattanooga Web Design your permission, it may also use personal identification information for internal or external marketing and promotional purposes.

On occasion, Chattanooga Web Design may collect personal identification information from you in connection with optional contests, special offers or promotions. Chattanooga Web Design will share such information with necessary third parties for the purpose of carrying out the contest, special offer or promotion. We will ask for your consent to such disclosure and use of such information, prior to your participation in the contest, special offer or promotion.

We will not share your personal information with any other third party.

d. ***Whether Information Has to Be Provided by You and Why***

The provision of name, address, and payment information is required from you to enable us to purchase access to our course or purchase other services we offer. We will inform you when we collect it whether you are required to provide the information to us.

e. ***How Long Your Personal Information Will Be Kept***

We will hold personal information for an undetermined amount of time.

f. ***Reasons We Can Collect and Use Your Personal Information***

Chattanooga Web Design collects and uses your personal information to send e-mails, fulfill orders, deliver services and products, complete customer transactions, oversee contests and promotions and improve website performance and customer service.

4. **Use and Transfer of Your Information Out of the EEA**

This website is operated in the United States and third parties with whom we might share your personal information as explained above are located in the United States and may be located in other countries as well. If you are located in the EEA or elsewhere outside of the United States, please be aware that **any information you provide will be transferred to the United States**. By using this website, participating in any of its services and/or providing your information, you consent to this transfer.

5. **Your Rights**
